SPECIAL CONDITIONS

1. In cases where sampling or transportation is carried out by the customer, the customer is responsible for sampling in accordance with the test conditions, transporting, packaging and keeping the sample until its acceptance in the test center.
2. The sample is accepted to the test center by the Test Personnel and/or the Quality Manager.
3. If the class requested by the customer is not specified in the classification tests, the appropriate class is selected by Dec-TC based on the customer's approval.
4. "Subcontracted laboratories" are not used in our testing services.
5. Decision Rule: When a declaration of conformity (suitable or unsuitable) is given regarding the test results, if there is a valid decision rule in the legislation, this decision rule is applied. If there is no valid decision rule in the legislation, the 'Simple Decision Rule' is used for the declaration of conformity and the results reported as is, without adding or subtracting confidence level and measurement uncertainty. Any requests to the contrary must be notified to our test center in an official letter.
6. Our Test Center will not disclose the results of its activities, commercial and statistical information, written and verbal information flow between the parties, in any way or form, without the prior written consent of the Customer. However, in cases where the Customer is required to disclose information about its activities to third parties who are officially authorized to ask in accordance with applicable laws, regulations or rules; If the legal authority wants to access information about the customer without the knowledge of the customer, the customer is not informed in cases where the law prohibits the sharing of information. In cases where the law does not prohibit, the customer is informed.
7. Information about the customer obtained from sources other than the customer (eg the complainant, the Ministry, etc.) will not be shared with the customer unless approved by the source who provided the information.
8. When a sample arrives that does not meet the sample acceptance criteria, if the customer wants the sample to test, Conditional Acceptance is made and the Statement of Renounce Form states which results may be affected by the deviations, and the Statement of Renounce Form is requested from the customer with a wet signature or scanned by e-mail. If a disclaimer cannot be obtained, the sample is not included in the test process.
9. After the test fee is paid, the test begins. The validity period of the form is 7 days, if the test fee is not paid or the sample is not delivered during this period, the request will not be considered.
10. The technical drawings of the sample to be tested must be submitted to Dec-TC Deceuninck Test Center in CAD platform (PVC profile, reinforcement, etc.). The details of the equipment used should also be specified.
11. When the test results are objected to, if the results confirm the first results, a retest fee is charged.
12. The test report cannot copy without the written approval of the test center. In case the report is received by hand, must to present the identity of the person receiving it.
13. The test results belong only to the sample that came to the test center.
14. Objection period to the Test Report is 7 days from the Report Issue Date. In case the sample is returned at the end of the test, the right to object to the Test Report disappears. Unless otherwise requested by the customer, the storage period of the remaining samples in the test center is 7 days from the date of the report. At the end of this period, samples that are not take back from the test center are disposed of. The objection period to the reports is the same as the sample storage period.
15. When this form is mutually signed, the contract becomes valid.
16. Price do not include 18% VAT.

CONDITIONS OF BRING SAMPLES TO THE TEST CENTER

1. All test samples; It is sent to the test center as mounted in a steel subframe (Subframe dimensions are confirmed by the test center). The subframe must be produced in accordance with its setsquare.
2. The test sample should be packaged in such a way that it will not be damaged.
3. The sample to be tested must be suitable for the test. The samples should not have any surface defects (holes, deep scratches, bending cracks, cracks).
4. The manufacturer's identification should be present on the sample.
5. The technical drawing should be submitted with the test sample.
